



breastfeeding welcome here

Breastfeeding is good for everyone









Decreases risk of Sudden Infant Death Syndrome (SIDS) and necrotizing entercolitis (NEC), leading causes of infant death

Decreases risk of ear infections, diarrhea, pneumonia and gastroenteritis in infancy

Reduces the incidence of childhood obesity, asthma, hypertension and some cancers

Improves IQ, academic performance and long-term productivity

Decreases risk of type 2 diabetes, breast and ovarian cancers for mothers

Saves families \$1,200 -\$1,500 on formula expenses in the first year of a baby's life

Reduces risk of mothers developing rheumatoid arthritis, high blood pressure and high cholesterol

Stregthens mothers' bones after weaning and reduces risk of osteoporosis Offers a 3-to-1 return on investment for business

Helps attract valued employees and lowers turnover rates

Boosts employee job satisfaction, morale, loyalty and productivity

Reduces \$312 million in annual healthcare costs in the U.S.

Results in fewer insurance claims and decreased employee absenteeism due to better infant health

Reduces global carbon footprint as it generally requires no packaging, fuel to prepare, or transportation to deliver

Does not create pollution or require disposal in a landfill

Creates a naturally renewable food source which is a complete source of babies' nutrition for the first six months of life

Promotes child spacing and helps control population growth



Breastfeeding Welcome Here FAQs



"Do I have to allow women to breastfeed at my business?"

Yes. The Kansas law protects a mother's right to breastfeed in any place that is open to the general public. This includes shopping venues, schools, restaurants, libraries and on public transportation. This law is, in part, based on feeding on cue - one of the key maternity care best practices. Feeding a baby on cue means that a mother is able to nourish and calm her hungry or upset baby. Because milk production works according to supply and demand, feeding on cue also means that mothers will be able to increase and sustain milk production for their growing baby.



"How do I respond if a customer complains about a woman breastfeeding?"

It is important to validate concerns as well as educate. "I understand you are concerned, but our business complies with Kansas law that protects a mother's right to breastfeed wherever she has the right to be. As a breastfeeding-friendly business, we support breastfeeding families and will not ask a nursing mother to leave or cover up. What can I do to make you more comfortable? Is there another place you would like to be seated?"

(Note: Solutions will be different for different businesses.)



"We are a family-friendly business. What about modesty?"

This is an understandable concern. Supporting breastfeeding families actually means you will be supporting more families. The vast majority of women who are breastfeeding are very discreet. They simply want to feed their child without worrying about being scolded. The more your community is educated about breastfeeding, the more it will be perceived as a normal (rather than controversial) act.

"Are there really that many mothers breastfeeding in public?"

Yes, 80% of mothers initiate breastfeeding in Kansas. People don't realize how often babies are breastfed in public because mothers and babies are so skilled at breastfeeding discreetly that it often doesn't register with viewers.

"Will my taking a stance on breastfeeding really make a difference?"

Yes! There are many barriers women face that prevent them from meeting their breastfeeding goals. However, mothers are more successful with breastfeeding when they have a supportive community where they live and work. Providing a comfortable, shame-free environment for breastfeeding mothers means that more families are able to have the freedom to be away from home and enjoy their communities.

"Why should businesses participate?"

Kansas law states "[a] mother may breastfeed in any place she has a right to be." Many Kansas businesses are already providing this level of access and comfort for their patrons. The campaign's aim is for businesses to demonstrate their support for breastfeeding by displaying a clearly visible window cling.

Breastfeeding Welcome Here

Every business knows the value of repeat customers and word-of-mouth. Breastfeeding moms who feel that they and their babies are welcome while they enjoy a meal, have a cup of coffee, or shop will return to your business and spread the word to their friends! Ensuring that your business is breastfeeding friendly gives you an opportunity to boost your business and benefit your local community at the same time.

Is your business "breastfeeding friendly?"

- Provide a welcoming environment— are breastfeeding mothers able to sit anywhere and enjoy a welcoming attitude from staff, management and other customers while breastfeeding?
- Supportive staff- Is the staff trained to handle complaints about breastfeeding? Concerned customers are informed that breastfeeding in public is protected by law and that your business welcomes breastfeeding patrons.
- By placing a "Breastfeeding Welcome Here" decal in your window, you make an important statement to your customers.

Kansas state law, § 65-1,248 protects a mother's right to breastfeed any place she has the right to be. It also states it is Kansas public policy for a mother's choice to breastfeed be supported and encouraged to the greatest extent possible.

Breastfeeding moms need a supportive environment. Breastfeeding is very important to the health of both mother and baby. Mothers who breastfeed are at a lesser risk of breast and ovarian cancer and breastfeed babies are less likely to suffer from infections, allergies, childhood diabetes and obesity.

We all benefit from breastfeeding. Breastfed babies are healthier, making fewer demands on public health services. Parents of healthy children take less time off work. Breastfeeding is also environmentally friendly — there is no manufacturing, pollution, packaging or waste involved! Furthermore, more mothers who feel comfortable feeding their babies in public places equal fewer crying infants, which makes for a better shopping, dining, etc. experience for all of your customers.
