

# Lactation Billing Manual

## Introduction

Increasing equitable access to lactation services is an essential component to enhancing continuity of care across sectors. In order to increase sustainable workforce development and career opportunities for lactation support providers, billing for lactation services must be optimized to create a system that values the provision of lactation services. Lactancia Latina en el Suroeste de Kansas (LLSWKS) set out to explore billing procedures for lactation services with support from the Kansas Breastfeeding Coalition (KBC).

## **Pilot Billing Cohort Activities**

Invitations were sent to individuals within the LLSWKS 19 county service area working in various settings to participate in a Pilot Billing Cohort to share learning experiences and experiments related to billing for lactation services. Participants worked within nonprofit and for-profit hospitals, local health departments, WIC agencies, and private lactation practice. Kansas Medicaid Managed Care Organizations representatives were active participants. The Pilot Billing Cohort met monthly from February through July 2023 to discuss lactation billing and to participate in peer sharing.

## **Billing Essentials**

Submitting services for insurance or Medicaid payment involves the following components:

- Provider type (*physician, registered nurse, lactation support provider, etc.*) only recognized provider are able to bill Medicaid and private insurance directly. Currently in Kansas, lactation support providers are not able to bill Kansas Medicaid directly since they are not a recognized provider.
- <u>National Provider Identifier</u> (NPI) the individual providing services has an NPI number and local health departments have an NPI number.
- Coding successful payment for services requires using the correct ICD-10 and CPT codes that accurately represent what occurred during the lactation consult. See Table 1.1 and 1.2 for list of codes.

#### **Success Stories**

Two local health departments in Kansas were successfull in obtaining payment from a private insurance company for lactation support services provided by an International Board Certified Lactation Consultant (IBCLC). The lactation consults were performed in the health department.

## **Suggestions to Incorporate Lactation Services**

Incorporating the offering of lactation services within current models as a standard practice is essential to increase opportunities to bill for lactation services. The following suggestions for incorporation have been identified through the shared experiences of the Pilot Billing Cohort.

Add lactation counseling to standard services such as:

- Prenatal visits
- Postpartum visits
- Well child checks
- Immunization appointments
